

# International Society of Nephrology (ISN) Membership Policy

# 1. Membership Period

The membership of the International Society of Nephrology (ISN) runs from January 1 to December 31 each year.

# 2. Membership Fees add hyperlink to both type and income level

<u>Membership fees</u> are based on the type of membership, as well as the current country of residency of the member. The fee structure reflects the economic status of the member's country of residence.

# 3. Membership Nature

ISN membership is unique, individual, and non-transferable. <u>Membership benefits</u> cannot be shared with other individuals.

# 4. Printed Journals

For members opting to receive printed journals, both the fees and mailing will be based on the country of residency.

# 5. Change of Residency

If members change their country of residency during the membership year, additional fees may apply based on the new country of residency. Members must notify ISN of any changes in residency promptly to ensure proper handling of their membership and benefits.

# 6. Membership Categories

<u>Membership categories</u> are based on the information provided by the member. If the information provided is insufficient or fraudulent, ISN reserves the right to limit membership benefits at any time. The ISN Council may terminate the membership by a two-thirds majority vote following notifying the member of the grounds for the proposed membership termination and giving the member the opportunity to appear before the Council and submit any writings or documents in support of the member's position.

# 7. Fraud Prevention

If there are legitimate doubts of fraud, including but not limited to misrepresentation of residency or sharing of membership benefits, ISN reserves the right to limit membership benefits at any time. The ISN Council may terminate the membership by a two-thirds majority vote following notifying the member of the grounds for the proposed membership termination and giving the member the opportunity to appear before the Council and submit any writings or documents in support of the member's position.

#### 1. Membership and Subscription Period

The membership/subscription period runs from January 1 to December 31. Discounts applied midyear will only cover the remaining months of the current calendar year unless otherwise specified.

# 2. Printed Journal Shipping

The printed journal will be shipped monthly. Please allow approximately 8 weeks for the first issue to arrive. Delivery is subject to local postal services, and delays beyond the control of the publisher are not the responsibility of ISN.

# 3. Address Changes

<u>Subscribers must notify ISN of any change of address at least 6 weeks before</u> the next issue is due to ensure continuous delivery.

# 4. Replacement of Lost or Damaged Issues

<u>Requests for replacement of lost or damaged issues must be made within 90 days of the expected</u> <u>delivery date</u>. Replacement of issues is at the discretion of ISN.
