## **Candidate's Statement**

Clearly, other ISN essential actions such as seeking to increase public awareness of CKD, connecting kidney professionals, support high-level research, education and training in nephrology must be continued.

I have also been involved within the ISN since my beginnings as recipient of a Fellowship Award and then as member of several committees.
